 - a. The deadline for questions regarding this RFP is 2:00 p.m. April 8, 2019. All questions will be answered in Addenda posted on the District website www.Southfield.k12.mi.us and emailed to bidders who provided email addresses at the pre-bid meeting. Emailed questions preferred.
 - b. Interviews are scheduled for April 23, 2019. Format: 5-10 minute presentation by vendor followed by a question and answer session. Vendors will be provided the questions before the interview. No food.
 - c. There are 8 CEP schools in the district: Adler Elementary, Stevenson Elementary, Vandenberg Elementary, Levey Middle School, Thompson K8, Southfield Regional Academic Campus, ASPIRE Academy, Kennedy Learning Center. 89.1% reimbursement.
 - d. The food service truck driver is provided by the FSMC.
 - e. The Kennedy Learning Center is a special education school that includes medically fragile students. Some of these students IEP's require blended or chopped food. Blenders and choppers are on site.
 - f. Breakfast Grants- Oakland Better with Breakfast grant recipients: Adler, Stevenson, Vandenberg, Thompson, Levey, Southfield Regional Academic Campus. Breakfast in Classroom starting in elementary schools. Breakfast served at bus entrance hallway at Southfield Regional Academic Campus and Southfield High School for the Arts & Technology. Working with United Way for breakfast participation increase.
 - g. The 2019-20 calendar is not available at this time. It is anticipated to be similar to the 2018-19 calendar attached.
 - h. Kitchen Health Department licenses and free and reduced application printing are District expenses.
 - i. On half day in-service days a bag lunch is served to the elementary buildings no lunch is served at K-8 and secondary buildings. There are 9 half days per year.

j. This contract begins on July 1, 2019. Three programs run during the month of July. SFSP at Southfield High School for the Arts & Technology and Beech Woods Recreation Center. The SMP operates at the Kennedy Learning Center in July and August..
